


LOCATIONS IN THE WELLINGTON REGION



Chairperson's Report

From the Board of Trustees, I would like to extend my thanks to an incredible array of supporters for what has been a very busy and rewarding year for Kaibosh Food Rescue.

We are very aware that the success of our organisation is dependent on the contribution of many individuals, organisations and businesses and we are very thankful for the incredible level of support that we are so lucky to receive.

2017–2018's highlight for our Board was undoubtedly the re-establishment of our City base in its new permanent home in Hopper Street. The opportunity to create a new facility in the Hopper Hub has given Kaibosh the confidence and energy to look toward a bright future of growth and continued positive impact.

2017–2018 was our busiest year yet with almost 248 tonnes of food reaching those most in need in our community. With the new base now in operation we are expecting the next year to be even busier, as Kaibosh celebrates ten years of service across Greater Wellington.

Fundraising is a significant focus for Kaibosh and our team works hard to ensure that we are operating 'in the black'. The Wellington community continues to rise to the challenge of financially supporting Kaibosh and this was clearly demonstrated with record involvement in our fundraising activities and events through the year. My own highlights were our All Taste, No Waste event presented in collaboration with Weltec, our Make a Meal in May campaign and Garage Project's ever popular Kegs for Christmas.

2018 saw us solidify our relationship with our official Patron, the Governor-General, Dame Patsy Reddy. Dame Patsy's keen support of our work was demonstrated through several visits to Kaibosh's bases along with hosting an incredible Christmas Party for Kaibosh volunteers and supporters at Government House.

The past financial year saw our Board farewell a number of longstanding board members and I would like to thank Ken Allen, Beth Brash and Nicole Taylor who have made an amazing contribution to the successful growth of Kaibosh over the years. Our new treasurer Paul Harford joined the Board in December and we have recruited two other fantastic new board members who will commence in the new financial year.



In 2018 we commenced investigations into a third Kaibosh base in the Kapiti-Horowhenua area. Funding permitting, we hope that this will be established in 2019 and that the positive environmental and social impacts, that Kaibosh assists to achieve, can be seen in this northern region.

I would like to again thank our many, many supporters for the numerous ways in which you all support Kaibosh. We are extremely fortunate to have such a level of positive backing.

General Manager's Report

The 2017–2018 Financial Year was a year of forward movement for Kaibosh as we emerged from an earthquake-disrupted 2016–2017 and re-established our city base in a new premises. After a year of operating out of a temporary base, the opportunity to relocate to a permanent home arose at the end of 2017 and we spent the early months of 2018 preparing the site with operations commencing from the Hopper Hub community enterprise base in March 2018.

Our service saw a record 247,698kgs of quality surplus food rescued and redistributed among 77 community groups, each supporting people in need. We continue to focus on providing assistance to organisations that are serving the most at-risk, marginalised and struggling members of our community. All organisations that are supported by Kaibosh are required to deliver a range of services, in addition to the provision of food, empowering individuals and families to move toward independence and a better quality of life.

Kaibosh's volunteer programme continued to grow, in line with the growth in food volumes. At the end of the financial year we had a total of 230 amazing individuals assisting our work across Kaibosh's two bases. I want to recognise the efforts of all of our volunteer team – they are the engine that drives Kaibosh and ensure we reach the outcomes we achieve.

We have continued to be supported by an extremely generous group of institutional and individual funders. Running Kaibosh costs in excess of \$500,000 per annum and the strong philanthropic support of our community is essential to our success.

Likewise, the food production and retail sector have continued to stand alongside Kaibosh and our work. All food provided to Kaibosh is donated free of charge and having the support of the business community is imperative to our operation. During the past reporting year 67% of all food rescued and redistributed by Kaibosh has been fresh produce, dairy and meat. Kaibosh continues to work to provide as high a percentage of healthy food to our partner charities as possible. This is the food which is so important for healthy families and individuals yet is so often difficult for those in our community who are struggling to acquire.



All of us at Kaibosh are very aware of our good fortune in being so well supported in the delivery of our work and I would like to extend my heartfelt thanks to all who continue to stand alongside us.
